AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS AND RESERVATION OF EASEMENTS FOR THE COLONIAL MANOR SQUARE HOME OWNERS ASSOCIATION

WHEREAS, J-II Homes, Inc., and J. Harold Maggard, Trustee, are the owners of lots 3768, 3846 3866, 3871, 3872, 3875, 3877, 4168, 4169, 4170, 4173, 4176, 4197, 4198, 4199, 4201, 4202, 4203, 4206, 4208, 4210, 4211, 4212, 4215, 4216, 4217, 4315, 4317, 4319, 4320, 4323, 4324, 4325, 4326, 4328, 4329 4330, 4331, 4333, 4334 and 4437 through 4410 inclusive, in the Colonial Manor Square Subdivision, have presented a written instrument signed by at least two-thirds (67%) of the owners of all the lots in Colonial Manor Square Subdivision described in Exhibit "A" attached hereto, as required by Declaration of Covenants, Conditions and Restrictions and Reservation of Easements for Colonial Manor Square Home Owners Association recorded in Vol. 6432, Page 677 of the Butler County, Ohio records pursuant to Article VI, Section 6.3.

WHEREAS, the Declaration of Covenants, Conditions and Restrictions and Reservation of Easements for Colonial Manor Square Home Owners Association Section 5.3.7 is hereby amended to permit the construction and placement of storage sheds or out buildings as follows:

A storage shed or out building shall be permitted in the rear yard of each lot if it is constructed of brick or vinyl siding and a roof which shall match the house. Said storage shed or out building shall not exceed 150 square feet and 10 feet height. Said storage shed or out building shall be 10 feet off the property line and shall not be located within the building line or easements.

**THIRD AMENDMENT TO THE DECLARATION OF COVENANTS,
CONDITIONS, RESTRICTIONS, AND RESERVATION OF EASEMENTS
FOR COLONIAL MANOR SQUARE HOME OWNERS ASSOCIATION, INC.**

WHEREAS, the Declaration of Covenants, Conditions and Restrictions and Reservation of Easements for Colonial Manor Square Home Owners Association (“Declaration”) was recorded in Volume 6432, Page 677 of the Butler County, Ohio Recorder’s Office;

WHEREAS, an Amendment to the Declaration of Covenants, Conditions, and Restrictions, and Reservation of Easements was recorded on October 6, 2003 at Book 7234, Page 685 of the Butler County, Ohio Recorder’s Office;

WHEREAS, an Amendment to the Declaration of Covenants, Conditions, and Restrictions, and Reservation of Easements was recorded on January 3, 2007 at Book 7842, Page 1738 of the Butler County, Ohio Recorder’s Office;

WHEREAS, Article VI, Section 6.3 of the Declaration permits the Owners to amend the restrictions by an instrument in writing recorded in the Recorder’s Office of Butler County, Ohio, signed by the then Owners of not less than two-thirds of the Lots included in Colonial Manor Square Subdivision;

WHEREAS, over two-thirds of the Owners desire to amend the Declaration;

NOW THEREFORE, pursuant to Article VI, Section 6.3 of the Declaration, the Declaration is hereby amended as follows:

1. Section 5.3.7 of the Declaration is hereby amended to permit the construction and placement of storage sheds or out buildings as follows:

A storage shed or out building shall be permitted in the rear yard of each lot if it is constructed of brick, vinyl or wood siding and a shingled roof. The color of the siding and roof shall match the house. Said storage shed or out building shall not exceed 150 square feet and 14 feet height from the ground to the highest point of the roof. Said storage shed or out building shall be 10 feet off of the property line and shall not be located within the building line or easements.

As amended herein, the Declaration and all Amendments thereto remain in full force and effect, with the exception of Amendment 1, which has been superseded in its entirety by this Amendment 3. By execution of this document, the President of the Association certifies that at least two-thirds of the Lot Owners have consented to this Amendment, and their consents are collectively attached to this Third Amendment as Exhibit "B."



